

Planning an internship can be complicated and sometimes confusing. It is an excellent exercise to prepare for life after graduation though.

Asking yourself the right questions will help you master internship planning and will ensure that your internship experience goes as smoothly as possible.

The internship experience is part of a bigger picture.

- Internships have an important academic dimension: i) academic requirements apply to all internship registrations, ii) the internship is a part of your academic experience at AUP, and iii) you will need to submit academic assignments following the end of your internship.
- Internships can greatly influence your career planning. Be in touch with the <u>Career Development</u> <u>Office</u> if you wish to discuss this further.
- Internships also exist as part of a web of options and constraints. Don't neglect legal and practical aspects such as: the local internship legislation, visa requirements, your budget, housing options, etc.

We strongly encourage you to use the **internship planning checklist** (downloadable on website or see appendix).

1. Location

Do you have any desires or requirements to consider (funding, housing, family, future career development, language) based on the location of your internship?

- If you are receiving U.S. governmental loans, please review location guidelines of where you can complete your internship to receive funding. Indeed, it is important to note that in order to be eligible for US federal loans, BA and MA students have to do their internship outside of the United States (New regulation by the U.S. Department of Education valid as of 1 July 2011).
- Ask yourself if you will need a visa to intern and contact the relevant authoritie(s).

2. Credit vs. non-credit?

- Undergraduate students may register an internship for 1 or 4-credits. 3-credit internships registration are exceptionally granted if the student is 3 credits short of graduation. A 2 credit internship is not possible.
- Credit-bearing internships may count as general elective courses, but only a maximum of 4 internship credits may be counted towards graduation.
- MCB students may register an internship for 4 credits. MAGC students may register an
 internship for 8 credits. Students from other Master's programs may replace a class by a 4-credit
 internship if approved by their MA Program Director.



- Students who wish not to receive credit for their internship still need AUP to issue documentation in connection to the internship (convention de stage or enrollment certificates). Therefore, they must register their internship for 0-credit. French law stipulates that a 'voluntary' or 'non-obligatory' internship in France must be in line with the student's course of studies (i.e. in the field of the major and/or minor, or of the MA Program).
- Please keep in mind that there is a fee for all internship registrations.

3. When should I do and register an internship?

a. Student status and internships

French law stipulates that internships are reserved for currently enrolled degree-seeking students. Once a student has been coded as a graduate, he/she can no longer do an internship.

Therefore, you must double-check that you will indeed still have student status in the semester in which you are planning on registering the internship with AUP. Under certain conditions, you main be able to do a final internship (stage de fin d'études). Please review information about graduation deferment in this brochure or on the website.

b. Please consider which semester(s) would be the best suited for doing an internship

Credit requirements

Bachelor's students must have earned at least 32 credits before they can register an internship.

Master's students must have earned at least 16 AUP credit before they can register an internship.

Doing a full-time internship



If you are thinking of doing a full-time internship, please consider the following options: taking a semester off, doing a summer internship, registering your internship as your last requirement or deferring graduation to register a final 0-credit internship.

Part-time Internships while studying

Taking classes 2 days a week and working 3 days a week can work very well for strong, dedicated students, but can be extremely challenging for students with a low GPA who need to improve their academic performance. Minimum GPA requirements for internship registration are currently 2.00 for Bachelor's students and 3.00 for Master's students.

Please discuss your particular situation with the Internship Coordinator.

Doing a summer internship

The full course load in summer is 2 classes (maximum 11 credits). If one is an internship, the classes can run simultaneously. If a credit internship is done on top of the 2 courses during the summer semester, the internship must begin after the end of summer session (mid-July). Tuition is based on a credit-by-credit charge in the summer. Credit for an internship which starts after summer session will not be charged on an overload tuition rate. Instead, the usual per credit tuition rate applies. Summer is the most popular time to do full-time internships.

General recommendations – applicable to all

We recommend that you take into consideration living expenses and the registration fee in the planning of your internship. Please check section 2.

We recommend that internship representing a degree requirement (CM, MAGC, etc.) be done towards the end of the students or full-time as the very last requirement.

Please remember that you can register several internships with AUP. We encourage you to discuss how best include several internships as part of your curriculum with the Internship Office, the Career Development Office and/or your Academic Adviser.

c. Ask yourself if you need to defer graduation to register an internship

When looking for jobs – especially in France – candidates are often offered an internship that precedes employment. According to French law, when a student graduates, he/she ceases to be eligible for an internship. Therefore, it may be advantageous for students to postpone their graduation by one semester and register a final internship with AUP to improve their chances of finding employment just before or directly following graduation. Registration of the internship with AUP ensures student status for one additional semester and allows the student to obtain the required *convention de stage* to intern in France.

Deferring graduation and registration of the internship may also be necessary for an internship taking place abroad (i.e. visa application, request of the hosting organization, legislation of the country where the internship is taking place, etc.).

4. Paid versus unpaid?

Do you need to be financially compensated for the internship or is the learning experience going to be valuable enough?

- FYI, internships taking place in France are paid a small remuneration when lasting more than 2 months or 44 days. To learn more, please download the following brochure.
- FYI, internship taking place within international organizations are most of the time not compensated. Consider if this could become an issue before accepting an offer.

5. Type of organization and type of internship
