

# **TAX STAMPS- "TIMBRES FISCAUX"**

**BY THEM ON LINE-** *Before* you buy them on line, check your situation first with SIS

<u>IMPORTANT:</u> you can <u>NO LONGER</u> buy the tax stamps in a Tabac. Only the tax stamps bought on line (<u>https://timbres.impots.gouv.fr</u>) are accepted by the French Authorities.

# 1) OFII PROCEDURE-

- ➤ A €60,00 TAX STAMP IS REQUIRED BY THE OFILE
- DO NOT BUY IT UNTIL YOU RECEIVE A CONFIRMATION FROM SIS
- ➤ BUY IT ON LINE BEFORE YOU GO TO THE OFII VISIT <a href="https://timbres.impots.gouv.fr/">https://timbres.impots.gouv.fr/</a>
- > IF YOU HAVE ANY QUESTION, FEEL FREE TO ASK SIS

# 2) RESIDENCY RENEWAL PROCEDURE-

- ➤ A TAX STAMP (either €49,00 or € 79,00- check with SIS) IS REQUIRED BY THE PREFECTURE DE POLICE TO WITHDRAW THE RESIDENCY CARD "TITRE DE SEJOUR"
- > DO NOT BUY IT UNTIL YOU RECEIVE A CONFIRMATION FROM SIS
- ➤ BUY IT ON LINE BEFORE YOU GO TO THE PREFECTURE DE POLICE <a href="https://timbres.impots.gouv.fr/">https://timbres.impots.gouv.fr/</a>
- ➤ IF YOU HAVE ANY QUESTION, FEEL FREE TO ASK SIS






