The President is responsible for developing and realizing the University's strategic vision. In collaboration with the Board of Trustees and the rest of AUP's Leadership Team, President Schenck has for the past 13 years presided over the University's re-founding, including the full renovation of its campus and curriculum. She is responsible for establishing AUP's place on the global stage and, to that end, has served as president of the Association of American International Colleges and Universities (AAICU). In 2004, she cofounded AMICAL, a consortium of 29 American universities across Europe, the Middle East, Central Asia and North Africa that hold in common the mission of advancing teaching, learning and research through the collaborative development of member resources.



Currently based in the US, the Vice President for Presidential Initiatives works closely with the President and is charged with the planning and execution of external outreach and advancement initiatives, including alumni and parent relations and fundraising operations. The VP leads teams based in Paris and the US, spearheading strategic efforts to engage alumni and former students with the University via volunteer programs and virtual and in-person activities and events. The VP's role includes responsibility for building relationships with significant donors and prospects for capital support and fundraising priorities. The Office of Outreach and Advancement is also responsible for the cultivation and engagement of parents of current and former AUP students worldwide.
